Introduction

This is the ninth edition of the African lion (*Panthera leo*) Regional Studbook. Data for this studbook were compiled from questionnaires and personal communications received from zoological institutions in North America and in South Africa. This edition contains analytical data prepared by Poplink 1.3 version software. The entries in this studbook reflect only specimens of known origins, which can be traced back to a particular region in Africa.

The African lion is designated by CITES as an Appendix II species. African lions are not listed by the U.S. Fish and Wildlife Service.

As of 12 June 2012, captive population of pedigreed African lions was 219 (98.121.0), known to be exhibited in seventy one institutions. Since lions are continuing to decline in the wild, and are now being imported by North American institutions, the SSP and AZA Felid Taxon Advisory Group (TAG) have recommended that only lions of a known origin be bred. This studbook will serve to organize and improve the captive management of African lions.

Taxonomic History

In 1758, Linnaeus put all cats in the genus, *Felis* and named the lion, *Felis leo*. However, in 1857, Severtzov placed the lion in the genus *Tigris* with the subgenus *leo*. (ie: *Tigris (Leo) leo*). In 1867, Gray established *Leo* as the lion genus thus renaming the lion, *Leo leo*. However, the modern classification dating from Pocock (1917), placed the lion, tiger, jaguar and leopard in the genus *Panthera*. Presently, the authorities have established that *Panthera leo* (Linnaeus 1758) should remain as the current genus due to the result of common usage (Werdelin). Yet, Cabrera (Circa 1980) believes that *Leo* had priority because it was established earlier than *Panthera*. Unfortunately, the taxonomy of African lions remains problematic. Taxonomists continue to explore methods for determining the identification of subspecies which is critical for the accuracy of this studbook. Currently, ISIS lists eight subspecies (ISIS, 1995), whereas Weigel (1959) lists eleven subspecies and Helmut Hemmer (1974) lists five subspecies. The Felid TAG recognizes five subspecies: *azandica*, *senegalensis*, *nubica*, *bleyenberghi* and *krugeri*. Refer to the range map for exact geographical regions.

Historical Range and Habitat

African lions were once found throughout the entire continent, and have a broad tolerance of habitats. Optimal habitat is open grasslands with thick bush and scrub for cover when hunting and denning (Eloff, 1973). They adapt to virtually any habitat ranging from barren sub-desert to savannah grasslands to open woodlands. Lions are incompatible with human populations and now occur only in parks, reserves and undeveloped areas. The population of wild lions has decreased due to habitat alteration and the reduction of the lion's natural ungulate prey density (Guggisberg, 1975).

The West African lion, *P. L. sengalensis* (Meyer, 1826), is found from Northwest Africa to Central Africa (Chad, Cameroon, and northern Congo). The distribution of the Congo lion, *P. l. azandica* (Allen, 1924), is limited to the northeast Congo region only, and may be synonymous with *P. l. bleyenberghi*. The East African lion, *P. l. nubica*, (Blainville, 1843), is found in northeastern and eastern Africa. This includes the subspecies *massaicus*, *somaliensis*, *roosevelti*, and *hollisteri*. The South Congo lion, *P. l. bleyenberghi* (Lonnberg, 1914), is located in southern Zaire, Angola and northern Namibia. The South African lions, *P. l. Krugeri* (= *vernayi* with ISIS) (Roberts, 1929), is distributed from southern Namibia, Zimbabwe, Botswana, southern Mozambique to Kruger National Park, and Hluhluwe National Park in southern Africa.

STATUS IN THE WILD

An estimation of the number of animals in the wild is not available. It is obvious that lion populations are becoming increasingly fragmented, and only those populations in national parks and reserves are likely to survive (MaKacha & Stander, 1991). Lions which are found outside protected areas are generally viewed as problem or dangerous animals and are severely persecuted.



STATUS IN CAPTIVITY

Currently, there are 219 (98.121.0) living African lions of known origin located in North American Zoological Institutions. Of these, 79 (37.42.0) are founders. Seventy one institutions have been identified in the current studbook as facilities holding lions of known origin. Sixty seven institutions have recorded 231 (99.110.22) births in the past 10 years.

STUDBOOK SUMMARY

As of 12 June 2012, there are 219 (98.121) pedigreed African lions living in seventy one institutions. Seventy nine (37.42.0) founders are located in North American as well as African facilities. Presently, there is only one subspecies of pedigreed lions in North America: The South African lions, *Panthera leo krugeri*.
